

Terms and Conditions

1. Ad Schedule:

- Ads will air on Monday of the first week or the first Monday of the month based on subscription plan and scheduled booking

2. Ad Duration and Screen Selection:

- **Ad Duration:** Client has selected an ad duration of either 15 seconds or 30 seconds based on allocated budget.
- **Screen Identification Number (SIN):** Each VNTV Digital screen has a unique Screen Identification Number (SIN), which will be provided upon selection of location and placement.
- **Screen Types:**
 1. **VNTV Entertainment with Ads:** A mix of entertainment content and advertisements.
 2. **VNTV Non-stop Continuous Ads:** Dedicated screens for continuous advertisements without any interruptions.

2. Ad Display Duration:

Clients have the flexibility to choose the duration for their ad campaign, with the following options:

- Minimum display period: 1 week
- Maximum display period: 52 weeks

3. Payment Terms and Directions:

- **All Cheques or Bank Transfers are to be paid directly to the following Bank Account:**
